

C.C.R. section 10.12 Use of Lakes

The lakes and streams within the Property are intended for the use and enjoyment of REFLEC-TIONS property Owners, their guests and invitees and the enhancement of the entire REFLEC-TIONS property. To provide for the full enjoyment of the aforementioned bodies of water, to preserve water quality and to minimize erosion due to water turbulence, no combustion type engines shall, be operated on said bodies of water within REFLECTIONS without the express written permission of the Board of Directors, which permission may be arbitrarily withheld.

ROA Rules Rule 7.5 Fishing Rules

- A. All persons fishing on any lake within Reflections boundary shall prominently display a current recreation pass, issued by the Manager's office, at all times;
- B. Residents of Mallard Landing and Creekside may purchase a special ROA Recreation Pass that gives them permission to fish in Mirror Lake only;
- C. Fishing in any lake within Reflections shall be prohibited from one hour after sundown to one hour before sunrise:
- D. Violation of this policy will be subject to a fine by ROA and may be treated as a trespass violation under the South Carolina Code of Laws; and
- E. Boats are not permitted on Emerald Lake; and
- F. Fishing rules are posted on all 3 lakes and are available on our website.



DID YOU KNOW...

Richland County C&D Landfill Centers

Acceptable Land Clearing Debris: Brush & limbs, root mats & tree stumps, logs, vegetation, and rocks; Earthen material (clays, top soil, sands, gravels & silts

Acceptable Debris: Items physically attached to a structure, i.e., signs, mailboxes, vinyl siding and other structural fabrics; Bricks & masonry blocks; Cardboard packaging material; Dry paint cans& painted waste (includes lead-based paint); Dry caulking tubes; Fiberglass matting, pallets and crates, floor coverings pipes, glass plaster & plasterboard; Glass wire (optical fiber), polyfiberglass (highly polished), material used for shower stalls; Cured hardened concrete (may include rebar); Shingles & roofing materials; Structural steel; Insulation material, tiles (floor, wall & ceiling); Lumber (includes treated lumber); Mirrors, tubing & wall coverings; NO ASBES-

TOS CONTINING DEBRIS

Acceptable Brown Goods: Household Furniture and Lawn furniture (laminated, metal, plastic, PVC, vinyl, wooden); Non-motorized bulky outdoor children's toys; Swing sets

In short: Any and all yard debris unless contaminated

Any and all building/construction type materials usless contaminated or chemically treated Any and all furniture indoor & outdoor and appliances

DID YOU KNOW...

Bulk Items and/or Large Items

Bulk Items and/or Large Items are picked up by appointment only. No fee will be charged for pickup at a residential location. Place such items curbside on your designated appointment day by 7:00 AM. Such items must be placed separate from other pickup items, such as the recycling roll cart, yard waste pile, or garbage roll cart. Call 803-929-6000 for an appointment information and also instructions on whether bulk items and furniture can be picked up together.

Items identified as bulk (White Goods): refrigerator, stove, washer, dryer, dishwasher, hot water heater, or other large white good household items. Also allowed are metal grills (no gas or propane tanks), swing sets (disassembled and any concrete removed from poles or posts), push mowers (remove gas and oil) and bikes. Such items must be generated by the residential household from which they are collected. Doors on all items must be removed prior to pickup. Bulk Item - white goods such as a washer or dryer

Large items (Brown Goods): furniture, such as chairs, sofas, tables, mattresses and box springs. Other items that can be picked up are patio furniture and single form plastic pools.

Examples of items that are NOT included are gym equipment, pianos/organs, pool tables, <u>electronics including TV's</u>, exterior structures (such as fencing, decks, dog houses), interior remodeling debris (this includes toilets, sinks and tubs), 55 gallon drums, tires, gas engines or car parts.

Construction/demolition debris (to include carpet, padding, shingles, lumber, cement, sand, and dirt) is not eligible for collection at curbside by Richland County and should be taken to a designated Drop-Off Center.

Yard Waste Collection

Yard waste is collected weekly and should be placed in one pile within 6 feet of the curbside and not in the **traveled** part of the roadway, storm drain or drainage ditch no later than 7 am on your scheduled service day.

What will be collected:

Grass Clippings; Leaves; Pine Straw (no mulch); Sticks or small limbs (no longer that 4 feet and no bigger than 4 inches in diameter); Brush or clippings generated from routine landscape maintenance of residential properties (no stumps, roots or tree removal debris will be collected).

How to prepare your yard waste for collection:

Weekly collection will be limited to a pile no larger than 6 feet in length, 3 feet in width and 2 feet in height OR roughly the amount of two loosely filled roll carts OR six 30-gallon yard waste bags. Please keep your yard waste at least 3 feet from other carts, containers, cars, mailboxes and other obstructions that may prevent pick up. If you have additional yard waste or larger yard debris, visit a county drop center for disposal. If yard waste is found to be non-compliant, it will be tagged with a service notice with the reason why it was not collected and will need to be corrected. If not corrected, a citation may be issued and the property owner may be subject to fines.

Holiday Schedule for pickup

There will be **NO CURBSIDE COLLECTION** on **New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day and Christmas Day**. When collection is interrupted due to a holiday, your garbage, recycling or yard waste will be picked up the day following your usual pick-up day.
