A Note from the Manager's Desk

We have a lot of new community members so far this year, so I'd like to take a moment to highlight some important reminders:

With the pool opening this week, please make sure you have your amenity bracelets handy; we ask that everyone has them with you which helps us identify proper use of the amenities by community residents. The Pool Rules have not changed from last year, so make sure you review them and follow them, please and thank you. Please clean up debris when you leave the pool and if you have pool floats, make sure to take them with you when you. Per SCDES, we have installed a new outdoor foot/body rinse station near the pool. Solar panels heat the water in the reservoir to make use more comfortable. Please utilize this rinse station prior to entering the pool.

Additionally, if you are not present with guests/visitors then they are not permitted use of the pool. All owners and residents are required to accompany all guests when in the community.

We have a lot planned for the community this summer and I hope to see you all enjoying the weather, amenities and please make room on your schedules to attend our monthly membership meetings and events!
